Because of COVID-19 and the state's unemployment rate, we are anticipating an increase in requests due to participants losing unemployment, losing their home, their jobs and even more important their support systems. Due to COVID, we cannot hold the event this year so we are focusing our fundraising efforts on snail mail, email, social media and personal asks (while social distancing).
